### ADDENDUM 3

- 1. The RFP Timetable has <u>not</u> been changed from Addenda #1.
- Please note that the design continues to be defined but the bill of materials for the anchor bolts and other embeds <u>will not</u> be available prior to the tender closing. Please prepare your bill of materials to bid the project accordingly.
- 3. Please note that the Pricing Form has been revised, attached and this is the Pricing Form to be submitted with your tender response.
- 4. The Site Grading line item has been converted to an <u>Allowance Item</u> to be used to complete the site excavation, backfilling, compaction and fine grading. This change is to allow each bidder to prepare a complete bid while the final site grading design is being fully define and completed.
- 5. Sketch, SK-01 is attached which tries to show the extent of the grading for this project and an approximate volume of fill to be placed.
- 6. Item 3 has been broken down into the works required for each foundation as defined by the work on the drawings.
- 7. Do not price for the 2" concrete blinding layer shown on some drawings. It is expected that the rebar will be supported on chairs sitting on firm granular material. If this is not the case, a change order will be issued at that time.
- 8. Drawing S-303 Revision 0, attached, the base slab and the walls will be 6" thick, and the slab shall be 25 feet long and 10 feet wide, out to out, or 9 feet clear between walls.






